### "Electronic Health Record System – Latest Development in Hong Kong" 19 January 2011

I have the pleasure to invite the healthcare professionals in different disciplines, the management staff and IT teams of your hospital/organisation to join the subject seminar which is organised by the cHcalth Record (eHR) Office of the Food and Health Bureau of the Government of the Hong Kong SAR.

Being an essential infrastructure for healthcare reform in Hong Kong, the territory-wide patient-oriented eHR System aims at providing an electronic platform for sharing patients' health records between the public and private healthcare sectors. Healthcare professionals in both public and private sectors would be able to enter, store and retrieve patients' health records, subject to patients' consents and proper authorisation for access to the system, ultimately realising the objective of "records follow patients".

Time flies and we have entered the second year of the development programme. We have just completed a fruitful year by developing the blueprint for eHR core infrastructure and Clinical Management System extension projects, rolling out the radiological image sharing pilot with private hospitals, piloting the use of Smart ID for patient authentication, and commencing the implementation of first stage eHR engagement initiative with the private healthcare sectors. This seminar will let you know the work done by our dedicated colleagues and the latest progress of the programme. Apart from sharing eHR updates, the seminar will also serve as a two-way communication platform which your feedback on eHR development will be much valued.


